**DECLARATION OF ROBB MCWILLIAMS**  
**IN SUPPORT OF REORGANIZED**  
**DEBTORS' THIRTY-SIXTH SECURITIES**

1 I, Robb McWilliams, pursuant to section 1746 of title 28 of the United States Code, hereby  
2 declare under penalty of perjury that the following is true and correct to the best of my knowledge,  
3 information and belief:

4 1. I am a Partner and Managing Director at the firm of AlixPartners, LLP  
5 (“**AlixPartners**”), which is an affiliate of both AlixPartners, LLC and AP Services, LLC, (“**APS**”).  
6 APS was previously retained to provide interim management services to PG&E Corporation and  
7 Pacific Gas and Electric Company, as debtors and reorganized debtors (collectively, “**PG&E**,” the  
8 “**Debtors**,” and as reorganized pursuant to the Plan, the “**Reorganized Debtors**”) in the above-  
9 captioned chapter 11 cases (the “**Chapter 11 Cases**”). I submit this Declaration in support of the  
10 *Reorganized Debtors’ Thirty-Sixth Securities Claims Omnibus Objection (Insufficient Substantive*  
11 *Allegations Claims)* (the “**Omnibus Objection**”), filed contemporaneously herewith.<sup>1</sup>

12 2. In my current position, I am responsible for overseeing the bankruptcy case  
13 management component of AlixPartners’ assignment to assist the Reorganized Debtors with  
14 various matters related to these Chapter 11 Cases. My areas of responsibility include (a) the effort  
15 by AlixPartners, in coordination with the Reorganized Debtors, to review and assess the validity  
16 of all claims asserted against the Debtors, other than Fire Claims and Subrogation Wildfire Claims,  
17 and (b) providing support with respect to Securities Claims. I am generally familiar with the  
18 Reorganized Debtors’ day-to-day operations, financing arrangements, business affairs, and books  
19 and records. Except as otherwise indicated herein, all facts set forth in this Declaration are based  
20 upon my personal knowledge, the knowledge of other AlixPartners professionals working under  
21 and alongside me on this matter, my discussions with the Reorganized Debtors’ personnel and the  
22 Reorganized Debtors’ various advisors and counsel, and my review of relevant documents and  
23 information. If called upon to testify, I would testify competently to the facts set forth in this  
24 Declaration. I am authorized to submit this Declaration on behalf of the Reorganized Debtors.

25 3. The AlixPartners team under my supervision has been actively and intimately

1 involved in the claims review and reconciliation process. AlixPartners initially assisted the Debtors  
2 in the preparation of their bankruptcy schedules based on the Debtors' books and records.  
3 AlixPartners is now supporting, and will continue to support, the efforts of the Reorganized  
4 Debtors and their counsel to resolve disputed claims, including by formal objections as necessary.

5 4. As part of the claims review and reconciliation process, the AlixPartners team,  
6 working with the Reorganized Debtors' personnel and other professionals, identified a number of  
7 filed proofs of claim for which Claimants included addenda containing potential allegations  
8 against PG&E.

9 5. The Omnibus Objection is directed to the Claims identified in **Exhibit 1** attached  
10 thereto, in the column headed "Claims to Be Disallowed and Expunged." **Exhibit 1** to the Omnibus  
11 Objection was prepared by the AlixPartners team under my overall supervision, and I am familiar  
12 with the document, its contents, and the process under which it was prepared.

13 6. On July 28, 2023, the Reorganized Debtors served notice of the Amendment and  
14 Objection Procedures Order on all Securities Claimants, as described in the August 17, 2023  
15 *Certificate of Service of Victor Wong Regarding Order Authorizing Amendment And Objection*  
16 *Procedures For Securities Claims* [Dkt. No. 13960] and the October 9, 2023 *Certificate of Service*  
17 *of Alain B. Francoeur Regarding Order Authorizing Amendment And Objection Procedures For*  
18 *Securities Claims* [Dkt. No. 13973].

19 7. In accordance with the Amendment and Objection Procedures Order, Claimants  
20 had until October 6, 2023 to amend their proofs of claim to allege facts supporting their purported  
21 securities claims against PG&E, and until October 13, 2023 to adopt allegations from a complaint  
22 already filed with another claimant's proof of claim. In the event that a claimant failed to amend  
23 their proof of claim or adopt the allegations of a complaint, their claims would be subject to a  
24 sufficiency objection under a standard akin to Federal Rule of Civil Procedure 12(b)(6). None of  
25 the Claimants identified on **Exhibit 1** amended their proofs of claim or adopted the allegations of  
26 a complaint.

1 Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true  
2 and correct to the best of my knowledge, information, and belief.
